state of conservation of the real estate, to request and exonerate from the production of documents such as certifications

of conformity, energy certification, to indicate modality and means of payment and, finally, to perform, with regard to said

purchase, whatever is necessary or useful to carry out that which is explicitly stated in this power of attorney, having from

this time forth approved and validated the actions of the proxy.

This mandate is gratuitous and shall have validity only for the present purpose.

I, the appointed Notary Official, have prepared and read the present act, with regard to the original in Italian, before the

witnesses and the appearing party, and the interpreter has done the same with regard to the translation in English, also

before the witnesses.

This act in its original form in Italian has been written in its essential parts by me the Notary Official, and in its totality is
